(A Constituent College of Mangalore University)

I. Aim of the Research Policy:

The research policy of the college aims to create and support a research culture among its teachers, staff and students and leverage it for enriching and enhancing the professional competence of the faculty members; for developing and promoting scientific temper and research aptitudes of all learners; for realizing the vision and missions of the college and for contributing to national development by establishing an institutional fund and plan for facilitating their participation in research and related activities and by providing the required resources and appropriate facilities.

It also aims at ensuring that the research activities of the college conform to all applicable rules and regulation as well as to the established standards and norms relating to safe and ethical conduct of research.

II. Purpose:

The purpose of the Research Policy is to create a vibrant atmosphere of research among faculty and researchers in University College Mangalore. The policy shall serve as an overall framework within which research activities may be carried out.

III. Scope of the Research Policy

This policy shall apply to the members of the staff and the research scholars pursuing their Doctoral studies in the institution. This policy shall apply to all research-oriented activities that would be taken up by the staff and students of the college. The policy covers publication and presentation of the research outcomes and related activities which are meant to make research socially relevant. It also includes knowledge compilation and helping the researchers to gain access to new fields of research, resources required for research and to enable peer review of their research activities.

IV. Objectives of the Research Policy:

1. To create an environment fostering a research culture by providing the required support to the researchers
2. To improve and strengthen the institutional capacity for enabling research in various disciplines.
3. To help researchers procure funding options available through schemes leading to knowledge development.

4. Ensure publications in quality journals
5. Encourage interdisciplinary research and collaborations to translate research into socially useful and feasible projects.
6. To provide a common format for the proper coordination of all research activities of the college so that they are aligned to the desired parameters.
7. To guide faculty members in the effective integration of research themes with curriculum enrichment activities.
8. To identify and keep the researchers informed about research opportunities announced by Government organisations, industry or any research organisation.
9. To encourage and facilitate the dissemination of research output through workshops, seminars, guest lectures etc.
10. To make researchers aware of the ethical and legal norms to be followed in research.
11. To ensure that the academic staff engages in the desired proportion of teaching, research and consultancy output, on a regular basis.

V. Research advisory body

Research advisory body and administrative committee shall be responsible for overall functioning of research activities within University College.


The Activities for the forthcoming Academic year 2019-20 was chalked out. The following were the listed out activities.




