





 Those who have put in two years of service with or without break, shall be considered for appointment, if they are atherwise qualffied.

(Those people who have joined prior to revised U.G.C. norms and if they were qualified at the time of first appointment according to norms prevailing then, they shall also be considered).



- All these appointments shall have the concurrence of Board of Appointments in respective subjects.
- 3. The appointments be given against the vacant posts that are available in the ratio of reservations, any excess claimed in any category should be compensated by making proportionate additional provision in the left out entegories.
- 4. These are fresh appointments and the appointees shall be an probation for a period of two years and their work place could be either the P.S. Department or the Constituent Colleges.
- They are not entitled to may kind of benefit because of past service and their service shall be counted from the date of reporting.
- 6. Those who are selected by the Board of Appointments through regular recruitment shall not be included. in the one time appointment".
